

POSITION DESCRIPTION

POSITION: Swim Instructor

Reports to: Swim School Coordinator and/or Programs Coordinator

Key Purpose

The Swim Instructor is a valued member of the Aquatic Centre team, responsible for delivering high quality aquatic programs. This role supports swimmers in having successful, safe and enjoyable experiences in the water, while serving as a positive role model.

Responsibilities and Duties

The Swim Instructor will be primarily responsible for ensuring the smooth delivery of the Learn to Swim program, the school PE program, and external school swimming programs.

You may also be asked to work with the GSV swimming squad (and would report to the Director of Sport)

This position description is not intended to be an exhaustive list of all duties, knowledge, or abilities associated with this position, but is intended to accurately reflect the principal job elements. You may be asked to carry out other reasonable tasks by management when necessary.

Key Duties

- Deliver lessons in accordance with the Mentone Girls' Grammar Learn to Swim program
- Be present, punctual, and prepared for all classes This includes arriving prior to the commencement of the class
- Ensure that students are appropriately attired (wearing a swim cap) and follow Aquatic
 Centre policies and pool rules
- Report accidents, injuries, or incidents to the Swim School Coordinator or Programs Coordinator
- Manage student behaviour and minor breeches. More serious problems should be reported to the Swim School Coordinator, Programs Coordinator, or Duty Manager
- Promote positive sporting conduct and act as a role model
- Participate in officiating duties as required
- Wear the Aquatic Centre uniform to work, and at work to maintain professionalism
- Follow all guidelines outlined in the Mentone Girls' Grammar Swimming Instructor Handbook.

Additional Duties

- Attend Aquatic Centre staff meetings, instructor training, and relevant school events
- Work flexibly and collaboratively in support of the School's Mission
- Other duties as required by the Aquatic Centre Manager or Principal
